

Privacy Policy

Pibideema PTY LTD is committed to providing a safe educational website for teachers, parents, and students. To help ensure a rewarding online experience for our visitors, we provide you with this summary of our information practices. As we continue to offer new and different types of content and services, we may modify our practices from time to time. However, we will treat all personal information we collect in accordance with the privacy policy in effect at the time the information is collected.

1. The Information We Collect

When users visit our site, users may be asked for personally identifiable information or we automatically collect some non-personally identifiable information to process and fulfill orders for products or services, such as the type of computer operating system (e.g., Windows XP or Mac OS), the browser being used (e.g., Internet Explorer, Firefox), and the domain name of the Internet service provider (e.g., Big Pond, Telstra).

We collect IP addresses to obtain aggregate information on the use of www.pibideema.com.au. An IP address is a number assigned to your computer by a Web server when you are on the Web. When you are on our site, we have a back-end server that logs your computer's IP address. We only use the information we find out from tracking IP addresses in the aggregate, such as how many users entered a specific area of our site, and not to track a specific IP address to identify an individual user. However, we may use such information to identify a user if we feel that there are, or may be, safety and/or security issues or to comply with legal requirements.

Pibideema PTY LTD ensures that all personally and non-personally identifiable information that it receives via the Internet is secure against unauthorized access. This means that no eyes but ours or those of contractors and agents performing services for us will ever see the information that our visitors send to us unless we indicate otherwise.
